Changes in PTS Market Open Time

Please be advised that Chi-X Japan ("Chi-X") will change the Market Open Time for Chi-Alpha/Chi-Select and the Order Acceptance Start Time of Chi-Match.

Chi-X currently operates the continuous limit order matching PTSs (Chi-Alpha and Chi-Select) from 8:00-16:00. While PTS trades are regarded as off-exchange transactions, Chi-X is required as stipulated on the JSDA rule to properly implement trade suspension measures in case price sensitive information arises and the details are uncertain. In light of this requirement, Chi-X has been, during 8:00-8:20 when the primary exchange would not trigger trade suspension, independently collecting, assessing relevant information, and taking action if necessary.

Chi-X will start handling margin orders from December 2, 2019. Because we expect the client base would significantly expand along with this development, we have decided to align with the primary exchange in the operation of trade suspension. The changes below are outcome of this decision.
